1. Establishment of Quorum, Call to Order and Introductions

6. Introduction of new UCPD Executive Director (*information item*)

G. Trussell introduces herself and lists some of her priorities for the position, including an umbrella approach to UCPD projects and setting up a direct pay system with the City of San Diego.

7. Bankers Hill Outreach Intern Project Report (information item)

B. Lorenzana shares some of her experiences while interning for UCPD. With regards to one of her outreach flyers, the BHNPC recommends she adds language specifying that the 4 hour TLS will only be enforced from 8:00am to 5:00pm.

8. Approve Chris DeMoville for full time employment as the Bankers Hill Project Manager (action item)

- **11.** Bikeway/Angled Parking Update (*information item*)
 Staff reviews the June 2, 2017 meeting with SANDAG and EDD staff regarding the planned angled parking changes, with a focus on timelines and developing processes for the next steps.
- **12.** Potential Locations for Curb Repairs- 4th to 6th Ave, from Date to Upas (*information item*)

 Staff reviews the current process being developed to message the curb repair needs for Bankers Hill, and next steps in this process. G. Trussell would like to compile a district wide list in order to potentially develop an RFP for the entire UCPD.
- **13.** Angled Parking Municipal Code Amendments (*information item*)

 Staff reviews the changes to municipal code section 86.0104 on Angle Parking. These changes include a shift in process, so that angle parking can be proposed and initiated without needing city council approval.
